

VIP HOSTED MEETINGS PROGRAM

TERMS & CONDITIONS

1. Complimentary festival passes:

Participation in the FTT Fintech Festival and Future Identity Festival VIP Hosted Meetings Program provides a complimentary pass to the event, taking place on December 8 - 9, 2026, in Austin, Texas, for qualifying individuals.

2. Qualification:

To qualify, individuals must: (a) be responsible for buying or evaluating technology solutions for their company; and (b) agree to attend onsite meetings with participating sponsors, determined through a double opt-in process. The purpose of the program is to create value for all participants.

3. Registration deadlines:

If you register your ticket before midnight on Monday, November 2, 2026, your FTT Fintech Festival and Future Identity Festival ticket will entitle you to be considered for inclusion in the VIP Hosted Meetings Program.

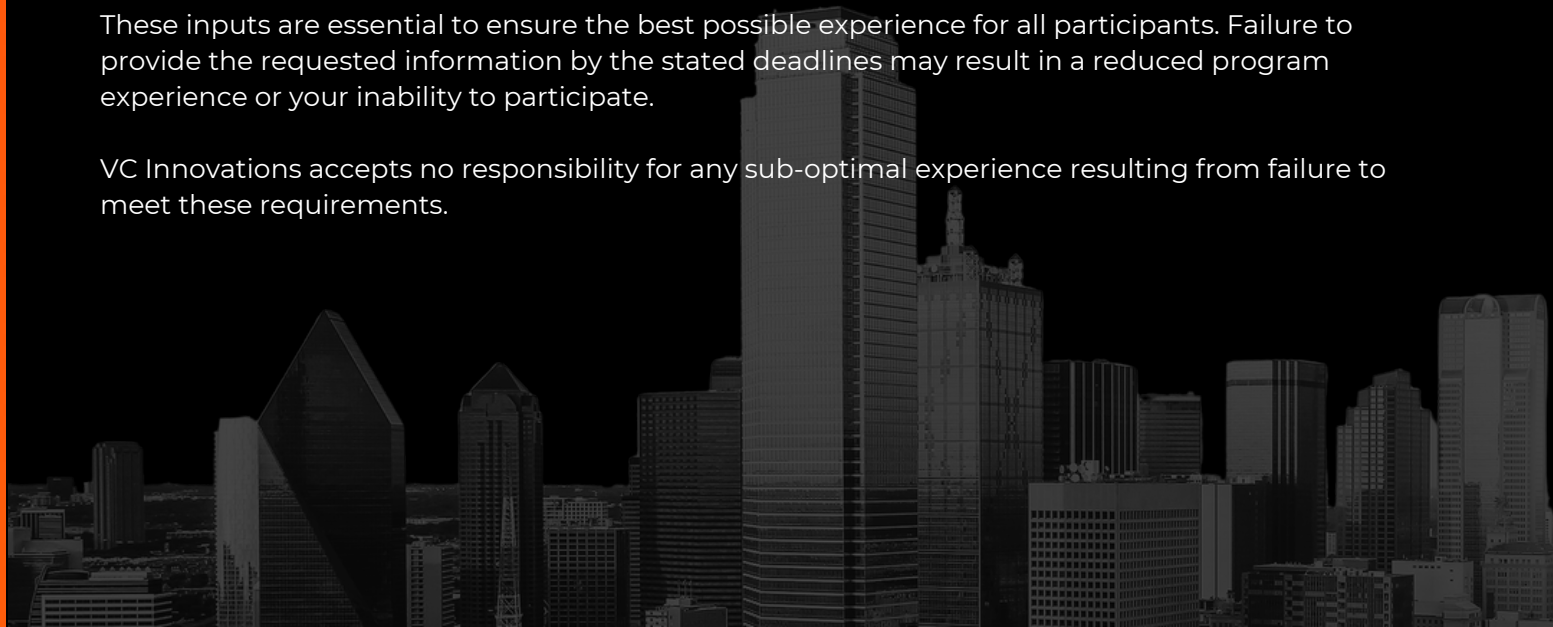
No extensions or exceptions can be granted to this deadline, and deadlines are subject to change at the discretion of VC Innovations.

4. Pre-event process and timelines:

The FTT Fintech Festival and Future Identity Festival team will provide clear guidelines and deadlines for the information required ahead of the event as part of the VIP Hosted Meetings program.

These inputs are essential to ensure the best possible experience for all participants. Failure to provide the requested information by the stated deadlines may result in a reduced program experience or your inability to participate.

VC Innovations accepts no responsibility for any sub-optimal experience resulting from failure to meet these requirements.



5. Meeting times:

You must commit to being available during the dedicated VIP Hosted Meetings program sessions on December 8 - 9, 2026, at 10:30 - 12:00 pm and 2:00 - 4:00 pm .

Please keep these meeting times available until you receive your final schedule shortly before the event. Your meetings may be spread across multiple hosted meeting sessions.

6. Travel arrangements:

You are responsible for making your own travel and accommodation arrangements to attend the FTT Fintech Festival and Future Identity Festival in Austin, Texas.

If any of your scheduled hosted meetings cannot take place in person during the event, they must be rescheduled and completed virtually within two weeks of the final day of the Festival.

7. Program participation:

We will contact you prior to the FTT Fintech Festival and Future Identity Festival to arrange your meetings through our hosted meetings platform.

You agree to participate in the process, including:

- sharing information about your company and role;
- selecting sponsors you would like to meet;
- adding your confirmed meetings to your calendar.

Your information will only be shared with relevant participating sponsors.

Following the event, you agree to provide feedback on both the VIP Hosted Meetings Program and each meeting, and to respond to requests within the stated deadlines.

Failure to engage with the process may result in you being disqualified from participating in future VIP Hosted Meetings Programs.

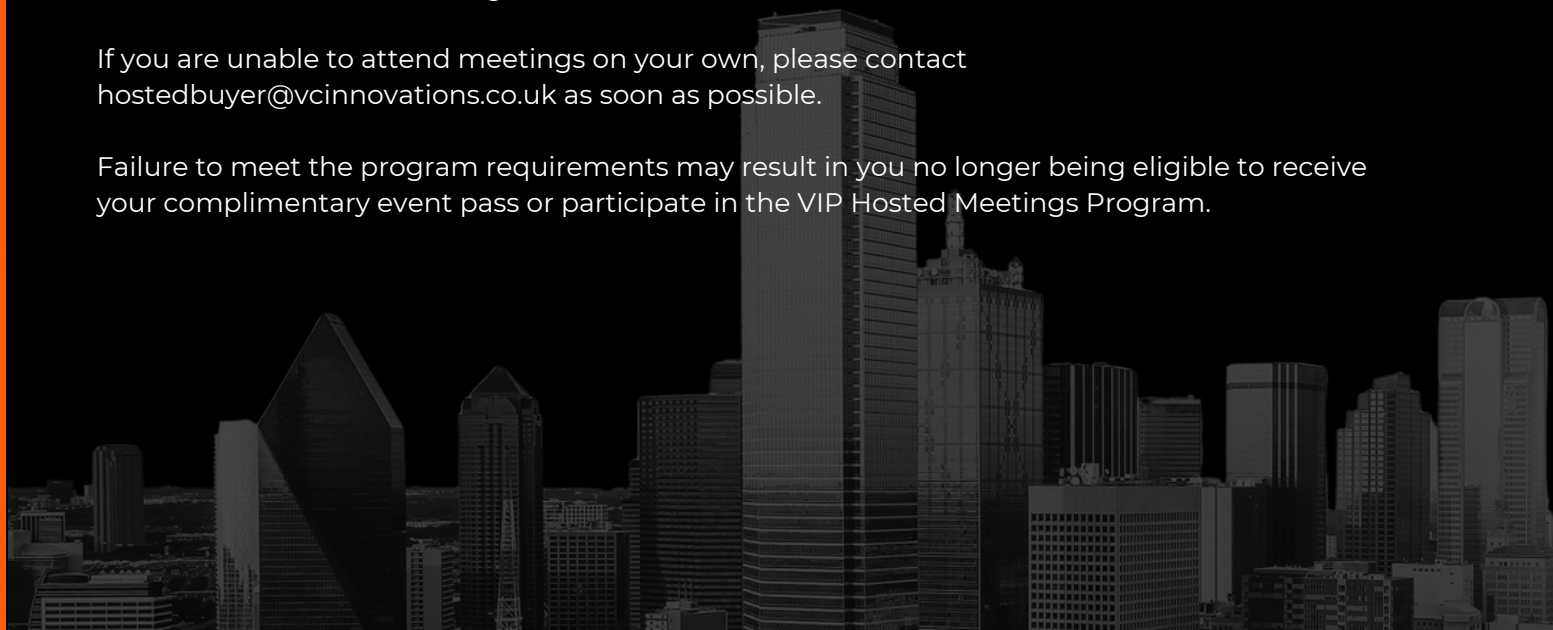
8. One-to-one meetings:

We will not accept requests to combine meetings with other individuals from your organisation who are also participating in the VIP Hosted Meetings Program.

If more than one person from your organisation participates, each individual must complete their own one-to-one meetings.

If you are unable to attend meetings on your own, please contact hostedbuyer@vcinnovations.co.uk as soon as possible.

Failure to meet the program requirements may result in you no longer being eligible to receive your complimentary event pass or participate in the VIP Hosted Meetings Program.



9. Failure to complete meetings:

If you attend the FTT Fintech Festival and Future Identity Festival but do not complete your scheduled meetings:

- we reserve the right to invoice your company US\$1,499 (or the applicable full delegate rate) for your event pass, as authorised below; and
- you may be excluded from participating in future VIP Hosted Meetings Programs.

10. Cancellation & substitutes:

If you are approved for the VIP Hosted Meetings Program but are unable to participate, you agree to nominate one or more suitable substitutes from your organisation.

Any substitute is subject to approval by VC Innovations.

If you cancel and cannot provide an approved substitute, this may affect your eligibility for future VIP Hosted Meetings programs.

11. Notice of employment change:

If:

- you are no longer employed by the organisation under which you were approved before the Festival; or
- you will be serving your notice period at the time of the Festival, you must notify us as soon as possible so we can reassess your eligibility.

Depending on your new role and organisation, you may no longer qualify to participate or receive a complimentary event pass.

Failure to notify us may affect your eligibility for future VIP Hosted Meetings Programs.

13. Invoice details:

You agree to provide a business address for the invoice and authorise an invoice to be issued if you do not complete your schedule of meetings as described in section seven (7) above.

14. Information sharing:

VC Innovations reserves the right to share information you provide with participating sponsors throughout the VIP Hosted Meetings Program.

Your email address will only be shared with sponsors with whom you have confirmed meetings. Qualification for the VIP Hosted Meetings Program is determined by VC Innovations and may be revoked at any time.
